Comprehensive Liability Waiver & Release of Claims

PLEASE READ CAREFULLY — THIS IS A LEGAL DOCUMENT

By signing this agreement, you acknowledge and agree to the following:

1. Assumption of Risk

I understand that participation in Wildwood Curiosity Studio activities involves inherent risks, including but not limited to:

- Interaction with soil, plants, water, and natural materials
- Exposure to insects, allergens, and environmental elements
- Use of tools and art materials
- Interaction with live or preserved animals
- Movement within a space containing glass enclosures, aquariums, and delicate structures

I acknowledge that these risks may result in:

- Minor or serious injury
- Allergic reactions
- Illness or infection
- Property damage

I voluntarily assume **all risks**, both known and unknown, associated with participation.

2. Release and Waiver of Liability

I, on behalf of myself and my child, hereby release, waive, and discharge:

Wildwood Curiosity Studio, its owner, employees, contractors, and affiliates

from any and all claims, liabilities, damages, or causes of action arising out of or related to:

- Participation in studio activities

- Use of equipment or materials
- Interaction with other participants
- Conditions of the premises

This includes claims resulting from **negligence** to the fullest extent permitted by law.

3. Medical Consent

In the event of an injury or medical emergency, I authorize Wildwood Curiosity Studio to obtain medical treatment for my child.

I understand that:

- I am financially responsible for any medical care provided
 - The studio does not carry medical insurance for participants

4. Behavioral & Safety Agreement

I acknowledge that Wildwood Curiosity Studio is a **shared, hands-on environment** requiring:

- Safe movement (no running or rough behavior)
- Respect for materials, tools, and living elements
- Ability to follow instructions and maintain appropriate behavior

I understand that:

- Destructive, unsafe, or aggressive behavior (including throwing objects, damaging materials, or endangering others) is strictly prohibited
- My child must demonstrate sufficient impulse control to safely participate

Wildwood Curiosity Studio reserves the right to:

- Remove my child from an activity immediately if safety is compromised
- Dismiss my child from the program if behavior issues persist

No refunds are guaranteed in cases of removal due to behavior.

5. Participant Readiness

I affirm that my child:

- Can participate safely in a group setting
- Does **not require one-on-one supervision**
- Does not exhibit behaviors that would pose a risk to themselves, others, or the environment

I understand that Wildwood Curiosity Studio is not equipped to provide:

- Therapeutic services
 - Behavioral intervention services
